

## “PICK JACK’S POCKET” PROMOTION

### TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents (excluding NT) aged 18 years and over.
3. Employees (and their immediate families) of the Promoter, Participating Store (defined below) and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or cousin.
4. Entries into the promotion open at 9:00am AEST on 02/07/25 and close at 11:59pm AEST on 05/08/25 (“**Promotional Period**”).
5. A participating store is any online or in-store BWS store located in Australia that stocks the Eligible Product (defined below) and displays material relating to the promotion during the Promotional Period (“**Participating Store**”).
6. To be eligible to enter, individuals must, in a single transaction, spend \$25 or more on any Jack Daniels product (“**Eligible Product**”) at a Participating Store during the Promotional Period (“**Qualifying Transaction**”). In the event that a purchase receipt is not provided to an entrant for their Qualifying Transaction, it is the entrant’s responsibility to request such materials.

To enter, individuals must then, during the Promotional Period, visit <https://pickjackspocket.jackdaniels.com>, follow the prompts to the promotion entry page, input the requested details (including but not limited to their first name, last name, valid email address, date of birth, postal address and phone number), upload a photo of their purchase receipt and submit the fully completed entry form.
8. Upon submitting their entry, entrants will be notified instantly on screen, in writing, whether or not they have provisionally won an instant prize. All provisional instant winners are subject to verification. Upon verification, winners will be sent their instant prize. Winners of an instant prize will have their details published (first initial, surname and postcode) online at <https://pickjackspocket.jackdaniels.com> on 06/08/25.
9. Multiple entries permitted, subject to the following: (a) only one (1) entry permitted per Qualifying Transaction (regardless of the amount spent on Eligible Products in that Qualifying Transaction in excess of \$25); (b) each entry must be submitted separately and in accordance with entry requirements; (c) only one (1) entry per person per day; and (d) a maximum of ten (10) entries per person.
10. Entrants must retain a copy of their purchase receipt(s) for all entries as proof of purchase.
