

“BWS CASH SPLASH” PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents (excluding NT) aged 18 years or over.
3. Employees (and their immediate families) of the Promoter, Participating Store (defined below) and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

7. To enter, individuals must then complete the following steps during the Promotional Period:
 - Visit www.winning-drinks.com/BWS-Cash-Splash (or scan the QR code advertised at the Participating Store);
 - Follow the prompts to the promotion entry page;
 - Input the requested details and upload a scanned copy or photo of the purchase receipt for the Qualifying Transaction; and
 - Submit the fully completed entry form online.
8. Entrants will then be notified immediately whether they are a provisional winner of an instant prize. Entrants will also be entered into the Major Draw (defined below). All provisional instant winners are subject to verification. Upon verification, winners will be sent their prize.
