Who can enter?	<p>Only Victorian residents who:</p> <p>(a) are aged 18 or over; and</p> <p>(b) are a registered user, or sign up to be a registered user, of the FANZO app.</p> <p>Registration to the FANZO app (and, consequently, participation in this competition) is subject to the terms and conditions which apply to the FANZO app available at www.fanzo.com/en-au/terms-and-conditions, as amended from time to time.</p>
Who can't enter?	<p>Directors, officers, management and employees (and their immediate families) of:</p> <p>(a) the Promoter; and</p> <p>(b) the agencies, companies or participating premises/outlets associated with this competition.</p>
Where will the competition run?	The competition will run in participating Dan Murphy's and BWS outlets in Victoria only (including the online stores of those outlets and at www.jimmybrings.com.au for pick up/delivery in Victoria only) which are stocking specially marked cartons (Outlets).
